Sub: Govt. of India instructions to accept Cheques, Demand Drafts and online payments from customers by private hospitals / nursing homes.

Sir / Madam,

Kindly find enclosed herewith Govt. of India to letter No. 10/3/2016-Cy I dated 13/11/2016 issued from Ministry of Finance, Department of Economic Affairs, North Block, New Delhi vide which it is informed that a few cases of non-acceptance of cheques/Demand Drafts and online payment transfer from customers by certain business houses including hospitals have been reported subsequent to demonetisation of old currency notes of Rs.500 and 1000 from circulation.

In this regard, I am directed to convey that all private hospitals & Nursing Homes in Delhi are hereby instructed to comply with the directions given in the above mentioned letter.

All CDMOs are hereby instructed to visit the private hospitals & nursing homes in their jurisdiction to inspect that these instructions are being complied with by private hospitals & nursing homes and submit an action taken report.

Subject: - Request for appropriate action in rural area for distribution of small denomination notes and non-acceptance of cheques/Demand drafts by certain establishments after withdrawal of Rs 500 and 1000 bank notes

Sir/Madam

I am directed to inform that based on the reports received the following problem areas which may kindly be addressed on priority.

1. You are requested to identify rural pockets where availability of cash is a problem and provide all support to the Banks and Post Offices in order to ensure that the last mile distribution of small denomination of notes is done through mobile banking vans and Banking Correspondents(BCs).
2. It has been reported that certain business houses including Hospitals, Caterers, Tent houses etc. are not accepting Cheques/Demand Drafts and online payment transfer from customers. In such cases the customer may be advised to lodge their complaint to the concerned District Magistrates/District Administration for appropriate action against such establishments.
3. This may be treated as **MOST URGENT**.
