TERMS AND CONDITIONS

1. The auction of all the obsolete/ unserviceable items will be held as a single lot. The bid will be confirmed in favour of the person quoting the highest rate in respect of that vehicle. The auction will be held in the Guru Nanak Eye Centre.
2. **Only those bidders shall be eligible for bidding, who deposit refundable amount of Rs. 5,000/- (Rupees Two thousand only) by way of demand draft / pay order drawn in favour of "The Director, Guru Nanak Eye Centre, New Delhi 110002 on or before 24th August, 2018 up to 01.00 pm along with duly filled Annexure A.**

Writing their name, address, telephone/ mobile no. on the reverse side of the demand draft / pay order which will be refunded to the unsuccessful bidders on the spot.

3. To be eligible for bidding, the Bidder shall along with depositing the earnest money for complete lot of items, submit Written Bid/bids in closed cover in Performa (Annexure 'A'). The Written Bid/s shall not be less than the reserve price of the items, as mentioned in clause 9, but may be more than that.
4. At the time of auction, no bidder shall be permitted to bid for complete lot of items for an amount less than the reserve price of the particular complete lot of items as mentioned in clause 9 or the highest written bid received, whichever will be more.
5. The bid shall not be less than the reserve price or written bid submitted, if any, in relation to the items mentioned in the Annexure -II.
6. The committee will deal with the bidders directly and no middlemen/ agents/ commission agents etc. should be asked by the bidders to represent their cause and they will not be entertained by the committee. At the bidding, any bidder/s trying to form cartel with other bidders to otherwise influence the Bidding process may be evicted and his/their earnest money may be liable to be confiscated.
7. Conditional bid will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money already deposited by him shall stand forfeited.
8. The complete items mentioned in Annexure-II shall be sold to the highest bidder inclusive of Sales Tax, if any on the basis of amount quoted in the bid
9. **Reserve price** for the said lot is **Rs,79,000/-**
10. The Director/committee, in its discretion, reserves the right to reject or accept any or all the bids, partly or completely, at any time without assigning any reason therefore. The decision of the Committee of Officers conducting the auction shall be final.
11. It shall be presumed that the bidder has fully inspected the lot of items before the auction. The committee shall not be responsible and shall not entertain any complaint in respect of any discrepancy in the lot of items.
12. The officers /staff of the GNEC and their family members shall not be permitted to participate in the auction.
13. The successful bidder shall get the complete lot of items lifted from the centre as per rules, at his own cost and responsibility, immediately on the lifting of items, certificate may also be submitted to this office for acknowledgement. GNEC shall not in any manner be concerned with or

Responsible for lifting of items, and will have no liability whatsoever after the lifting of items by the successful bidder.

14. Successful bidders has to make full payment in the form of DD/ Payee Order in Favor of Director, GNEC within 7 days after confirmation , failing which the offer will be cancelled and the EMD shall stand forfeited.
